If you plan to attend our trail rides you must have all Mandatory Trail Equipment in your vehicle.

Mandatory Trail Equipment:

Front & Rear Recovery Points That Are Properly Frame Mounted In One Manner Or Another (Tow Hooks, D-rings, etc.)

Tow Strap Without Metal Hooks (No Chains!)

First Aid Kit (Basic Will Do, But More Is Always Better)

Fire Extinguisher

Spare Tire (Must Be Able To Get You Off The Trail And Back To Trailhead)

Suitable Jack For Your Vehicle (Hi-Lift Jack Recommended)

Minimal Supply Of Tools For Your Vehicle

Seat Belts (These Need To Be Worn!)

A FUNCTIONING 4x4 System

All Non-Hard Top Vehicles Must Have A Roll Cage

We recommend that you also carry some tools, rags, hand cleaner, extra oil and fluids and possibly a change of clothing. A more detailed list of suggested equipment is on the website.

I also agree to indemnify and hold harmless the Club, its members, officers, directors, delegates, instructors, agents, employees, representatives, servants or assigns from and against any and all claims, actions, suits, judgments, damages and costs, including reasonable attorney's fees, that may result by reason of any suit or other legal action that I either commence or assist with as described in the preceding paragraph. This Release and Indemnification Agreement shall bind me, my distributees, heirs, executors, representatives, successors and assigns.
